All Dogs are boarded at the rate of \$10.00 per day, regardless of size or weight.

All pets are boarded or otherwise handled or cared for by Kennel without liability on Kennel's part for loss or damage from disease, pests, theft, fire, death, escape, injury, or for other unavoidable causes; or injury or death to this pet(s) caused by any other animal(s) on kennel premises; or injury or harm to persons or property by said pet, or death or injury to any other animal caused by this pet during the term of this contract, whether the animal is on the Kennel premises or not. Owner hereby waives any and all rights which he may have against Kennel for any liability arising under this Contract for damages.

Unless other arrangements have been made, all charges incurred by Owner shall be due and payable upon pickup of pet. Owner further agrees that pet shall not leave the Kennel until all charges are paid to Kennel by Owner. If action is required by Kennel in order to enforce this contract, Owner agrees to pay all attorney and court costs in addition to any boarding and/or training charges.

Owner understands and agrees that if the dog is not picked up within 14 calendar days after the scheduled pick up date, the dog shall be deemed to be abandoned and additional boarding charges shall apply. Kennel shall gain legal custody and ownership of dog and retain the right to keep the dog as a pet or place the dog in a new home with a new owner, with no recourse by current owner.

If the pet becomes ill or if, in the Kennel's opinion, the state of the animal's health otherwise seems to require professional attention, Kennel, in its sole discretion, may engage the services of a veterinarian of its choosing, or administer medicine, or give other requisite attention to the animal, and all expenses arising thereof shall be paid by the Owner.

In the event that my pet should need veterinary services while in the care of Animal House, I request that the following conditions be adhered to:

_____ **Save my pet, regardless of the cost** of any necessary treatment, medication, or surgical procedures.

_____ Use any and all reasonable and customary treatments, medications, or surgical procedures necessary to treat my pet, **not to exceed \$**_____.

_____ **I do not want my pet treated by a veterinarian under any circumstances, even in a life-threatening situation.**

All provisions of this Contract shall be binding for this visit and all subsequent visits. Owner acknowledges having read this contract and agrees to abide by the conditions herein.
